# MEDIA STATEMENT WORLD ZAKAT AND WAQF FORUM 2025:

**Sponsorship Handover Seals Strategic Partnerships** 

**KUALA LUMPUR, 27 August 2025 –** The 14th World Zakat and Waqf Forum (WZWF) Annual Meeting and International Conference will be held from 13 to 15 October 2025 at the Hikmah Exchange Event Centre, Kuching, Sarawak. This landmark edition, organised in conjunction with the 70th Anniversary of Majlis Islam Sarawak, will be officiated on the first day by the Premier of Sarawak, Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari, a visionary architect of Sarawak's economic and development agenda; from digital economy initiatives to hydrogen energy, industrialisation, infrastructure, and rural development. He is also an avid supporter of Waqf as an enabler towards empowering social community development.

On the third and final day, the Forum will be honoured by a Special Prime Ministerial Keynote Address by the Prime Minister of Malaysia, Datuk Seri Anwar Bin Ibrahim underscoring Malaysia's leadership in positioning zakat and waqf as key enablers of enduring and inclusive development. The proceedings will then culminate in the pinnacle of WZWF 2025 — the Kuching Declaration, to be delivered by the Secretary General of the World Zakat and Waqf Forum, setting forth the shared vision and global commitments of the Forum.

In a special ceremony today held in Kuala Lumpur, major sponsorship contributions were officially handed over to the World Zakat and Waqf Forum (WZWF) as the main organiser and to Yayasan Waqaf Malaysia (YWM) as the Waqf Partner for WZWF 2025. The handover was witnessed by the Minister in the Prime Minister's Department (Religious Affairs), Senator Dato' Setia Dr. Mohd Naim Mokhtar, underscoring the Government of Malaysia's strong commitment to advancing Islamic social finance.

Their participation reflects the Forum's stature as a truly global platform, uniting thought leaders, policymakers, and innovators to reimagine zakat and wagf for the digital age.

Sarawak is poised to showcase its commitment to modern zakat and waqf development. This is not only a celebration of 70 years of Mailis Islam Sarawak but also the beginning of a new era of co-creation and service to the Ummah."
